- Check freight to insure it complies with TSA security regulations
- Process live animal and perishable shipments to comply with various federal agencies regulations
- Negotiate rates and space with the steam ship lines and truckers to obtain competitive rates when applicable
- Track and trace shipments
- Perform customer service duties
- Miscellaneous filing
- Label freight, check to insure that Dangerous Goods freight is properly packaged and labeled
- Comply at all times with standards and regulations to encourage safe and efficient business operations
- Attend meetings/training as required by management
- Perform other duties as requested by management
